The Atlanta Prosperity Campaign is a group of non-profit agencies, businesses and government organizations working together to help people like you meet your family's needs.

Services that the Prosperity Campaign can offer you:

• FREE income tax preparation services Visit a Volunteer Income Tax Assistance (VITA) site. Income-eligible households can have their tax returns prepared through the VITA program at sites all over the Metro Atlanta area. These sites are located at non-profit agencies, churches and libraries. When you come to have your taxes prepared, you can also learn whether you are eligible to receive the Earned Income Tax Credit (EITC).

· Access to public benefits

Learn about accessing all the public benefits that are available to you. Many Atlanta families are eligible, but are not applying for them! These benefits include the Earned Income Tax Credit, Food Stamps, Medicaid, PeachCare, energy assistance, and others. Our sites provide programs that help you determine if you qualify for any of these benefits, and can assist with the application process if you do qualify.

Access to a wide range of additional community services

Discover new resources if your family has difficulty making ends meet. Many families have challenges that require outside help. We have an easy-to-use website, **www.atlantaprosperity.org**, that lists organizations offering a wide range of services.
